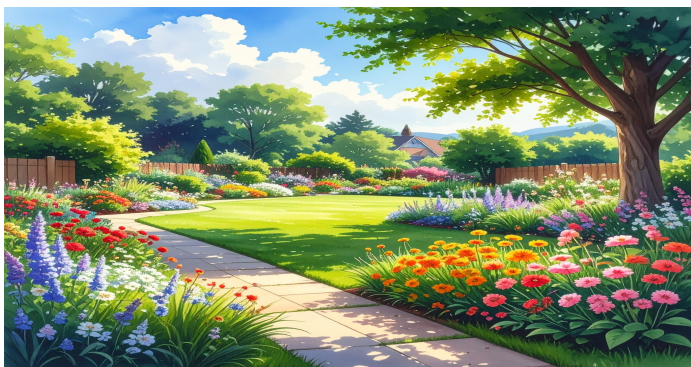
Rosedale RAC Update
